ABA MODEL CODE OF PROFESSIONAL RESPONSIBILITY

In its formal opinion No. 96-402 (Aug. 2, 1996) (Propriety of Payments to Occurrence Witnesses), the ABA Committee on Professional Ethics opined that its standards permitted compensation to non-expert fact witnesses for preparation time, including pretrial meetings with lawyers, and time spent reviewing and researching records:

Regarding the change to Rule 1.1's Comment, the ABA Commission on Ethics 20/20 explained: Model Rule 1.1 requires a lawyer to provide competent representation, and Comment specifies that, to remain competent, lawyers need to "keep abreast of changes in the law and its practice."
